

BICYCLE RENTAL REGULATIONS at the Grand Lubicz Hotel in Ustka

I. GENERAL PROVISIONS

- 1. These Regulations include the terms of use as well as the scope of rights and liability of people using the bicycle rental service at the Grand Lubicz Hotel in Ustka run by Uzdrowisko Ustka Sp. z o.o. having its registered office in Ustka (hereinafter referred to as the Renter).
- 2. The rented bicycles are owned by the limited liability company Uzdrowisko Sp. z o.o. having its registered office in Ustka. The bicycles (hereinafter referred to as the Equipment) have front and rear lights, mudguards as well as identification numbers on them.

II. EQUIPMENT RENTAL CONDITIONS

- 1. The Equipment shall be rented by the Renter's authorised employee only to those who fulfil the following conditions:
 - 1.1 they are Guests of the Grand Lubicz Hotel,
 - 1.2 they are of legal age (which is verified based on their identification documents),
 - 1.3 possess the knowledge and skills necessary to use the rented Equipment correctly.
- 2. The Renter's employee may refuse to rent the Equipment to persons who do not fulfil the conditions mentioned above as well as to those being under the influence of alcohol, other intoxicants as well as medicines which either forbid or recommend to refrain from cycling.
- 3. Renting the Equipment takes place based on a Rental Contract signed by a Renter's employee and by a person who fulfils the conditions mentioned above and whom the Renter's employee does not refuse to rent the Equipment. The Contract includes among others the amount and numbers of the Equipment rented.
- 4. If after 24 hours of expected return date the Rentee does not return the Equipment or does not inform about changing the return date, the Renter may file a complaint about suspected bicycle misappropriation.
- 5. Equipment rental fees are included on the rental contract.
- 6. The borrowed Equipment must be returned by 22:00 (before the closing time of the Rental Shop). If, after the return deadline, the Renter does not return the Equipment or notify the Rental of a modification of the return deadline, the Rental may file a notice of suspected misappropriation of the Equipment.



III. RENTEE'S OBLIGATIONS

- 1. The Rentee undertakes to:
 - 1.1. use the Equipment in accordance with its intended purpose, excluding the Equipment used for professional sport or similar purposes,
 - 1.2. return the Equipment to the Renter in a non-deteriorated condition on the day when the Equipment in question is supposed to be returned,
 - 1.3. not to lend the bicycle to third parties,
 - 1.4. immediately notify a Renter's employee about any problems connected with using the Equipment, especially about the Equipment being damaged, lost or stolen,
 - 1.5. not to repair or modify the bicycle by themselves as well as not to replace any parts of the Equipment by themselves.
 - 1.6. to cover the costs of repairing the damage caused to the Equipment by the Rentee using the Equipment,
 - 1.7. in case of theft, loss of or total damage to the Equipment, to cover the costs or purchasing new Equipment.

IV. RENTEE'S LIABILITY

- 1. The Rentee bears full liability for any damage caused to the rented Equipment after it has been rented by the Rentee from the Renter. The damage shall be covered by incurring the costs of repairing or replacing the damaged elements based on the documents presented by the Renter. Should a Renter's employee accept the Equipment without reservations, the Rentee is free from any liability for possible damage caused.
- 2. In case of theft or loss of the bicycle the Lessee is obliged to pay a lump sum compensation to the Lending Library in the amount of Helmet 300 PLN, Children's bicycle 1 000 PLN, Trailer 1 500 PLN, Unibike bicycle 2 500 PLN, Trek bicycle 5 000 PLN, Beach trolley 600 PLN, Electric bicycle 20 000 PLN.
- 3. The Renter reserves the right to refuse to accept the Equipment back if the damage caused is of such a nature that the repair cost will be equal to or greater than the amount given in paragraph 2 above. In such a case, the Rentee is obliged to pay the compensation as defined in paragraph 2 above.
- 4. The Rentee bears sole liability for any damage caused to third parties which results from using the Equipment.
