REGULATIONS FOR PET ANIMALS IN GREEN MOUNTAIN 5* HOTEL & APARTMENTS



THE CONDITIONS FOR ACCEPTANCE

- 1. The basic condition for acceptance of pet animal in Green Mountain 5* Hotel & Apartments is to notify at the time of booking that a Guest will be arriving with a pet.
- 2. When making a reservation, the guest is obliged to specify the species / breed of animal. The facility reserves the right to refuse to accept animals whose species / breeds are commonly considered to be dangerous or aggressive, and in particular:

American Pit Bull Terrier,

Akbash Dog,

Anatolian Karabash,

American Bulldog,

Dogo Argentino,

Moscow Watchdog,

Caucasian Shepherd Dog,

Perro de Presa Mallorguin,

Canary Mastiff - Perro de Presa Canario,

Rottweiler.

Tosa Inu.

- 3. The animal's stay is conditioned by the animal's health records with current anti-rabies vaccinations and a deworming certificate.
- 4. To ensure safety, the animal should have a leash, collar, cage depending on the animal species.

Fee:

- 1. The fee for the stay of an animal weighing less than 15 kg is PLN 30 per day.
- 2. The fee for the stay of an animal weighing more than 15 kg is PLN 70 per day.

CONDITIONS OF STAY

- 1. Animals staying on the premises must not disturb other guests.
- 2. The places where an animal can reside are: room/apartment and Lobby Café & Bar.
- 3. The rooms and suites where animals will be kept will be cleaned only during the absence of an animal or during the owner's stay in the room.
- 4. During the animal's stay in the room/apartment, the owner is obliged to display information about the presence of the animal on the handle, on the outside of the door.

The hangers are available in the room/apartment.

5. The animal must be brought out on a leash, under the care of the owner or an authorised person.

6. In the event that employees of the facility have a reasonable suspicion that an animal left in the room disrupts the stay of other guests, destroys the property of the facility, or may cause a threat to itself or other guests, the Management of Green Mountain 5* Hotel & Apartments will try to contact the owner in order to solve the problem. If contact is not possible, the Management reserves the right to enter the guest's room also with the possible help of appropriate services and remove the animal from the facility. All costs resulting from the above activities are covered by the owner of the animal.

Hygiene and cleanliness:

- 1. The pet owner is responsible for the cleanliness afterwards: in the room and apartment, in public areas, as well as in the surrounding area. Please clean up after your pet.
- 2. The owners are obliged to clean the waste left by the animals on the premises and in the surroundings of the facility.
- 3. Do not let dogs on beds, sofas, chairs and other items of equipment in the facility.

Liability:

- 1. The pet owner shall be liable for any damage and contamination caused by the animal and shall be liable for any damage.
- 2. The amount of the fee for damages and contamination will be determined by the Management of Green Mountain 5* Hotel & Apartments.
