GAME ROOM REGULATIONS

1. GAME ROOM at Crystal Mountain Hotel***** in Wisła at ul. Bukowa 19A is managed by WISŁA MOUNTAIN RESORT OPERATOR spółka z ograniczoną odpowiedzialnością spółka komandytowa with its registered office in Warsaw (00-023) at ul. Widok 8 (KRS [National Court Register Number]: 0000678720).
2. In our GAME ROOM you will mainly find game consoles, which can be used free of charge by Crystal Mountain guests during GAME ROOM opening hours on the terms set out in these regulations.
3. GAME ROOM is intended exclusively for Crystal Mountain guests aged 12 and above.
4. A child up to 15 years of age should use GAME ROOM devices under the supervision of an adult guardian. Guardian is responsible for safety and should take care over his/her child during their stay at the GAME ROOM. Crystal Mountain does not provide the presence of a guardian for minor children for the duration of their stay in GAME ROOM and does not exercise care over minor children in GAME ROOM.
5. GAME ROOM offers games intended for people over a certain age. Guardian is obliged to ensure that the child only plays games that are adapted to his/her age, in accordance with markings on the packaging or displayed after their launch. Please contact Crystal Mountain staff if you are unsure about the intended use of certain games for a specific age group.
6. GAME ROOM cannot be used by people who may pose a threat to health or safety of other people staying within the area of GAME ROOM. For epidemiological reasons, people who are carriers of infectious diseases, viral and bacterial infections, and people with visible disease symptoms (increased temperature, cough, runny nose and others) cannot stay in the GAME ROOM.
7. The child's guardians should make sure that the child adheres to safety rules when using the GAME ROOM devices and equipment and does not behave in a way that threatens the safety of other children, e.g. by pushing, pulling, etc., or maliciously interfering with other children when playing in GAME ROOM.
8. Entering the GAME ROOM is possible only in clean shoes and without an outerwear. For hygienic reasons, GAME ROOM must not be entered barefoot.
9. All GAME ROOM equipment and devices (game consoles, elements of their equipment, games) should be used in accordance with their intended use. GAME ROOM devices can be connected to a power supply, therefore their use should be conducted with special care and the highest level of safety.
10. It is particularly forbidden to climb on the elements of GAME ROOM equipment, including tables and chairs. It is forbidden to destroy or interfere with the devices in the GAME ROOM.
11. It is prohibited to take any GAME ROOM equipment outside the GAME ROOM area, in particular devices used for gaming and games.
12. It is forbidden to chew gum, eat sweets, eat, or drink within the GAME ROOM area. It is forbidden to consume alcohol, smoke tobacco or tobacco products (including e-cigarettes) and use abusive substances. People under the influence of alcohol or drugs cannot stay within the GAME ROOM area.
13. Pets are not allowed in the GAME ROOM.
14. Persons who persistently do not comply with the GAME ROOM regulations despite reminders from Crystal Mountain staff may be asked to leave it by the hotel staff.
15. Persons staying within the GAME ROOM area are obliged to maintain order and cleanliness.
16. Persons staying within the GAME ROOM area should immediately report any defects and malfunctions of GAME ROOM devices or equipment to the Crystal Mountain reception desk.
17. Any damages, accidents or hazardous events should be promptly reported to the Crystal Mountain reception desk. Any items found within the GAME ROOM area should be handed over to the Crystal Mountain reception desk.
18. For security reasons, GAME ROOM can be monitored with surveillance cameras. The Controller of personal data is the company indicated in point 1. The purpose of processing personal data, i.e. the image of people in the GAME ROOM, is to ensure safety of people staying in the GAME ROOM, protect property and defend against claims or pursue claims, which constitutes legitimate interests of the controller specified in art. 6(1)(f) of GDPR. Further information on the rules of using video surveillance in the hotel can be found in the hotel's regulations and separate information on monitoring, available at the Crystal Mountain reception desk and in each hotel room.
19. These regulations are available at the entrance to the GAME ROOM, as well as at the Crystal Mountain reception desk and in each hotel room.
20. These regulations are valid from January 1, 2021.
